### STRUCTURE, GOVERNMENT AND MANAGEMENT

### Type of governing document

The Society is a charitable unincorporated association and the aims and administration arrangements are set out in the constitution.

#### Trustee recruitment and appointment

The affairs of the Society are managed by a Committee of up to twelve trustees. The constitution requires that the members of committee are appointed or reappointed at the Annual General Meeting. Between general meetings, if the number of trustees is below twelve, the committee have powers to co-opt a trustee or trustees to serve until the next Annual General Meeting.

#### **OBJECTIVES AND ACTIVITIES**

#### Charitable purposes

The charitable purposes of the Society are the advancement of education and the advancement of heritage, culture and the arts. The Society aims to promote the study of Family History in the area and to assist with research.

#### Summary of the main activities in relation to these objects

The Society publishes a Journal in April and August and a Bulletin in December which are sent to all members.

Volunteers do their best to help members with their research and to direct non-members to sources of information. Local members are encouraged to come to the afternoon Workshops. Distant members are given assistance by passing on information from local resources. Enquiries can also be sent by email or posted on the online Members Forum. Meetings of the Society, which visitors are welcome to attend, are held on the second Thursday evening of the month from January to May and from September to December.

#### Workshops, projects and special events

#### Workshops

These were held on Thursday afternoons throughout the year, with the exception of the second Thursday of each month. Members have the opportunity to speak about their particular interests or research, to use the Society's resources and to socialise.

#### Start of a new project

On behalf of Ayrshire Archives the Society have undertaken the transcription of some historical Kilmarnock Academy Admission Registers. These consist of over 200 A3 pages of about 5000 student records between 1870 and 1919 plus an index.

#### **Outing to the Lead Mining Museum at Wanlockhead**

On June 14<sup>th</sup> several members went on a visit to Wanlockhead in Dumfriesshire. We were escorted down one of the old lead mines, shown their living conditions, heard a talk at the Miners' Library and had a tour of the Mining Museum, a very informative visit.

#### **Visit to the Mitchell Library**

Our second outing of the year was on November 1<sup>st</sup> to Glasgow. We were given a tour of the Mitchell Library by two very knowledgeable guides through areas not open to the general public. At the end of the tour we sat down and discussed relevant family history records held in the library.

#### **FINANCIAL REVIEW**

#### Brief statement of the charity's policy on reserves

The Trustees review on a monthly basis the bank balance, receipts and payments and are aware of the difficulties in 'breaking even' each year. With this in mind it is policy to hold at least a year's operating costs in reserve in general funds. Additional reserves allow expenditure on special items or projects to be considered. Serious consideration will need to be given to the costs of the afternoon workshops in 2019, because, with the venue being under new management, there will be substantial charges for its use.

#### Details of any deficit

There was a deficit of £196.91 for the year. With rising costs for postage and no increase in membership, a deficit was expected. The amount of the deficit was helped by donations from overseas.

#### Donated facilities and services (if any)

East Ayrshire Council gave free use of a room in The Johnnie Walker Bond, Strand Street, Kilmarnock for the evening meetings.

East Ayrshire Leisure provided free use of a room in New Farm Loch Community Centre, Kilmarnock for Society workshops and committee meetings. This will not continue into 2019.

The charity benefits greatly from the voluntary services of its trustees in enabling it to provide services and maximise its charitable purposes.

#### OTHER OPTIONAL INFORMATION

#### Membership

At December 2018 the total membership of the Society was 137. The categories of membership were as follows: Life member 1, e-members 28, Overseas postal members 11, UK & Europe postal members 94, additional family members 3.

#### Website facilities for members

Members have the opportunity to browse back numbers of the Society's magazines and to post comments and enquiries on the online Members Forum.

The Society also has a Facebook Page.

#### Links with other societies

The Society is a member of the Scottish Association of Family History Societies [SAFHS] and is represented at their AGM and Council meetings.

The Ayrshire family history societies hold an annual joint meeting to hear a talk and to exchange information.

The Society is a member of the Ayrshire Federation of Historical Societies [AFHS] and sends representatives

to their AGM and 'Swap Shop' meeting.

The Society has a good relationship with Kilmarnock and District History Group [KDHG] and with Cumnock History Group [CHG].
